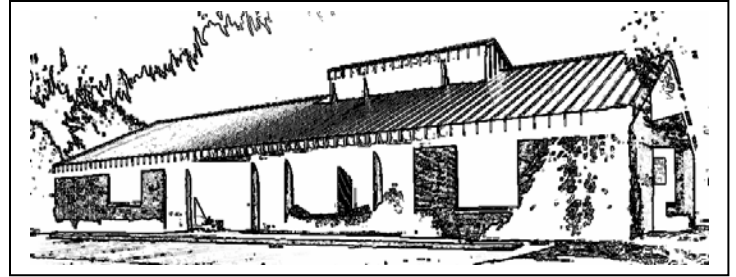

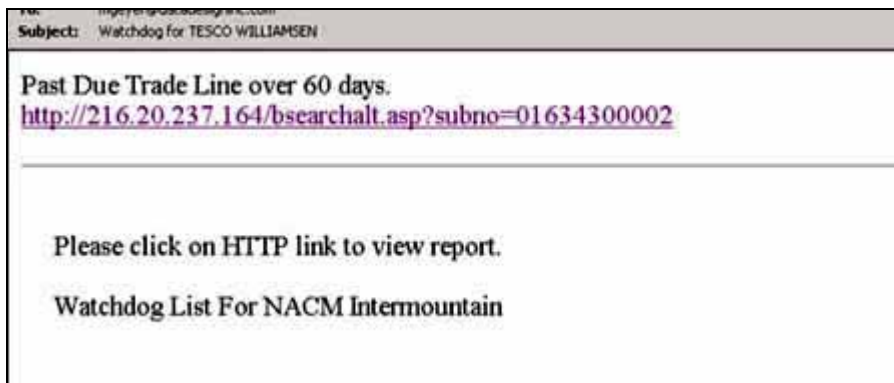

"Watchdog" or Account Monitoring

The watchdog service emails or faxes a notice to members that have either reported or inquired on a subject when there is negative or important activity, which includes:

- ✓ Past due trade data
- ✓ A claim placed for collection
- ✓ Legal or bankruptcy data
- ✓ "Flash" data
- ✓ A report of an Account written off
- ✓ UCC filings



Example of an email. The subject is identified in the title of the email. To purchase a copy of the credit report, the member 'clicks' on the hyperlink.
